Thinking It May Be Time For A New Ride? Maybe consolidate those rising debts? How about a vacation? The credit union can help. Anyone getting approved for a loan can automatically have their loan rate lowered by a 1/4% if they ask to sign-up for e-statements and eliminate the paper copy. **But you have to ask.** This offer ends July 1, 2017.

Protect Your Financial Well-being

Monitor your credit report. By law, you’re entitled to a **free report** every year from each of the three bureaus (Equifax, Experian, and TransUnion). Request one every four months, changing bureaus each time. You can order the report directly through each agency, or at annualcreditreport.com. Use this URL—there are hordes of knockoff sites that will try to charge you for your report and other needless services. Scan it for abnormal activity, such as accounts or credit cards you didn’t open. (And don’t fall prey to **fake free credit report advertisements**.) Start today by visiting our website, www.CTLaborFCU.com and click on the button called FREE CREDIT REPORTS.
